

## **Plan Development**

NPDES permits, POTW discharge permit, local, state, and federal regulations require most facilities to develop and implement one or more of the following pollution prevention plans: best management practices plan (BMP); spill prevention, control, and countermeasure plan (SPCC); Facility Response Plan (FRP); industrial activity stormwater pollution prevention plan (SWP3); construction stormwater pollution prevention plan; toxic organic management plan (TOMP); Accidental Discharge / spill and slug control plan (ADSCP). Referencing EPA guidance and other published documents as well as our extensive in-house experience, our staff prepares these plans, and our professional engineers certify them, as required. The plan development process is complemented by developing site-specific training programs, conducting training sessions, and performing site inspections.

## **Regulatory Support**

EQM routinely advises clients on the regulatory requirements associated with current operations, plant expansions, greenfield developments, and closures. We have worked on projects across the country and have the technical resources in our in-house library to support projects in all states, territories, and Canada.
